The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 05 day of FEBRUARY, 2026,

at approximately 3:05 PM, at 100 N OSCEOLA AVE, in Pinellas County did:

THE UNDERSIGNED SWEARS THAT HE/SHE HAS REASONABLE GROUNDS TO BELIEVE THAT THE ABOVE NAMED DEFENDANT ON 5FEB2026, IN PINELLAS COUNTY DID:

WILLINGLY AND KNOWINGLY WITHOUT AUTHORIZATION DISRUPTED, DENIED AND CAUSED THE DENIAL OF COMPUTER SYSTEM SERVICES TO AN AUTHORIZED USER OF SUCH COMPUTER SYSTEM SERVICES, WHICH, IN WHOLE OR PART, IS UNDER CONTRACT TO AND OPERATED ON BEHALF OF THE CITY OF CLEARWATER (COC). INVESTIGATION SHOWED HARMON DESTROYED AND DAMAGED THE CITY OF CLEARWATER'S COMPUTER SYSTEMS AND COMPUTER NETWORKS. IN DOING SO, HARMON INTERRUPTED OR IMPAIRED A GOVERNMENTAL OPERATION, PUBLIC COMMUNICATION, OR OTHER PUBLIC SERVICE (COMPUTERS WITHIN THE PUBLIC LIBRARY).

ON 10 FEBRUARY 2026, INFORMATION WAS GATHERED FROM THE COC IT DEPARTMENT INDICATING MISCONDUCT AND CRIMINAL ACTIONS BY A FORMER EMPLOYEE. THE INVESTIGATION SHOWED THAT JEFFERY HARMON MALICIOUSLY TAMPERED WITH NETWORK AND SYSTEMS, RENDERING THEM INOPERABLE. AN AUDIT LOGS FOR HARMON INDICATED THE FOLLOWING AND IS RECORDED: HARMON ON 5 FEB 2026 USED 'LIBRARYADMIN@MYCLEARWATER.COM' ACCESSED AND DAMAGED AND DESTROYED A SYSTEM CALLED DEEFPREEZE ON 200 COMPUTERS OPERATED VIA LEASE BY THE COC. INVESTIGATION SHOWED THAT JEFFREY HARMON CREATED THIS ACCOUNT ON 16 JANUARY 2026. IN ORDER TO DO THIS, THE SUBJECTS MULTI-FACTOR AUTHENTICATION WAS UTILIZED, SHOWING IT WAS HARMON WHO EXECUTED THE MFA.

ON 29 JAN 2026 FURTHER AUDIT LOGS SHOW THAT LIBRARY.ADMIN@MYCLEARWATER.COM WAS RESET BY HARMON. ON 5 FEB THE SAME ACCOUNT LOGS IN FROM AN IP ADDRESS LOCATED IN OLDSMAR (WHERE SUBJECT RESIDES). THE ONLY SUBJECT WITH ACCESS TO THIS ACCOUNT WAS HARMON AT THAT TIME, DELETING THIS PROGRAM OFF THE NETWORK RENDERED THE ENTIRE SYSTEM UNSECURE AND SUSCEPTIBLE TO INTRUSION / INFECTION BY MALWARE AND VIRUSES. THE RESULT WAS OVER 200 COMPUTERS ACROSS COC LIBRARY SYSTEM BEING SHUT DOWN AND TAKEN OFFLINE.

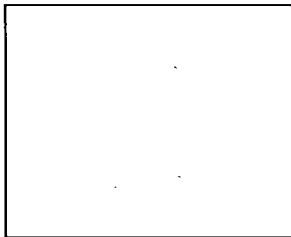
